Forest and Nature for Society (FONASO) is a three-year world-class Joint Doctoral Programme (180 ECTS). FONASO is part of the Erasmus Mundus programme initiated by the European Commission to enhance and promote European higher education throughout the world. The language of the programme is English. The main objective of the FONASO programme is to educate the leaders of the future generation of researchers, teachers and top management staff working with sustainable forest and nature management, in both tropical and temperate regions, to ensure wider societal benefits. Within forest and nature management, the programme is focused on the scientific fields of (i) economics and policy, and (ii) ecology and silviculture. The emphasis is on applied research.

Every year approximately 8-10 fellowships will be available to academically outstanding applicants. There is one annual call for applications; short-listed applicants are invited to Europe to present and discuss their proposals.

CLIR Call For Proposal on Cataloging Hidden Special Collections and Archives

Libraries, archives, and cultural institutions hold millions of items that have never been adequately described. According to a 1998 Association of Research Libraries' survey of 99 North American research universities' special collections, on average 15 percent of their printed volumes, 27 percent of manuscripts, and 35 percent and 37 percent of video and audio, respectively, are unprocessed or uncataloged. Nationally, this represents a staggering volume of items of potentially substantive intellectual value that are unknown and inaccessible to scholars.

OHCHR Minorities Fellowship

Through this Programme, the OHCHR aims to give persons belonging to national or ethnic, religious and linguistic minorities - particularly young minority women and men - an opportunity to gain knowledge on the UN system and mechanisms dealing with international human rights in general and minority rights in particular. The Fellowship Programme is intended to assist organizations and communities in protecting and promoting the rights of minorities the fellows belong to.

The Fellows are based at the OHCHR in Geneva, Switzerland. The programme is interactive and consists of briefings on several topics (e.g. the UN system, OHCHR's work, human rights mechanisms and instruments) as well as individual and group assignments.

At the end of the Programme, all Fellow should have a general knowledge of the United Nations system, international human rights instruments and mechanisms in general and those relevant to minorities in particular and be capable of further training their communities/organizations.

Scholarships at the University of Dublin

The Department of Political Science at Trinity College, University of Dublin, is one of the top Political Science departments in Europe. It is a vibrant, outward-looking department that combines intensive research activity with the strongest commitment to high quality undergraduate and postgraduate teaching. It is a member of the School of Social Sciences and Philosophy, one of around 24 schools within Trinity.

A background in a social science will be an advantage but not a necessity. Applicants are expected from candidates with a single or joint honours degree in Political Science, Economics, European Studies, History, Sociology, Business and Law. Other subject areas will also be considered.

The course is of twelve-months duration, on a full-time basis. Teaching starts in the autumn and the M.Sc. concludes with the submission of a dissertation the following September. Applicants must, in addition to the College requirement to provide academic transcripts and two letters of recommendation, provide a motivation letter and one piece of written work (for example an undergraduate dissertation or essay).

The International Fund for Agricultural Development (IFAD), a specialized agency of the United Nations, in partnership with the Consultative Group to Assist the Poor (CGAP), the European Commission (EC), the Government of Luxembourg, the Inter-American Development Bank (IDB), the Spanish Ministry of Foreign Affairs and Cooperation (MAE) and the United Nations Capital Development Fund (UNCDF), is pleased to announce the Financing Facility for Remittances (FFR) call for proposals on Promoting innovative remittance systems and investment channels for migrants.

The FFR, a US\$18 million multi-donor facility, aims to reduce rural poverty and promote development. The facility increases economic opportunities for the rural poor through support and development of innovative, cost-effective and easily accessible international or domestic remittance services, with or within countries in Africa, Asia, Europe, Latin America and the Caribbean (LAC), and the Near East.

IDRC Fellowships and Awards

This Fellowship (a bequest from Helen S. Bentley and C. Fred Bentley) provides assistance to Canadian and developing-country graduate students with a university degree in agriculture, forestry or biology, who wish to undertake postgraduate, applied, on-farm research with cooperating farmers in a developing country.

In principle, IDRC supports research on all parts of the developing regions of the world. At this time, Fellowships and Awards is not supporting awards which involve research in Burma, Cuba, Iran, Iraq, Eastern Europe or Central Asia.

Projects should evaluate and/or promote the use of fertility enhancing plants, such as leguminous forages, shrubs, cover crops, and grain legumes in small farms. The intent is to seek ways to increase the yield of food crops, improve farmers' livelihoods, and improve soil fertility.

The Fund focuses particularly on individuals who suffer from the most severe forms of human rights violations occurring in the context of slavery, as well as the most identifiable contemporary forms of slavery - chattel slavery, debt bondage, human trafficking, serfdom, child labour and servitude, forced labour, and/or forced marriage.

EC Call For Proposal on Promoting social cohesion, employment and decent work

The thematic programme 'Investing in People' pursues a broad approach to development and poverty reduction, with the general aim of improving human and social development levels in partner countries in accordance with the United Nations Millennium Declaration and the Millennium Development Goals (MDG). It is based on Article 12 of the Development Cooperation Instrument (DCI)¹, and is detailed in the Strategy Paper for the Thematic Programme 2007-2013. Part of the fourth theme of the programme - 'Other aspects of human and social development' - is dedicated to addressing inequalities and promoting social cohesion, fostering the 'decent work' agenda, and employment.

UN.GIFT Call For Proposal from Civil Society

Civil Society Organizations (CSOs) play a vital role in addressing the issue of human trafficking worldwide. They are an essential partner in all prevention, protection and prosecution efforts. Activities that CSOs engage in range from raising awareness, measuring progress of commitments made by other stakeholders, collection and analysis of data, and influencing public opinion. CSOs help governments in identifying victims of trafficking and offer direct services to them; such services include legal assistance, medical and psychological care, as well as supporting voluntary repatriation and reintegration, or the process of integration in the country of destination.

While CSOs around the world perform invaluable work, financial resources to fund their activities are often scarce. In order to support CSOs in their counter-trafficking activities, the United Nations Global Initiative to Fight Human Trafficking (UN.GIFT) has established a Small Grants Facility. Through a Call for Proposals, a total amount of USD 500,000 will be dispersed to selected CSOs in 2010.

On 1 March 2010, the Call for Proposals will be published on the UN.GIFT website inviting non-governmental, not-for-profit organizations working on counter-trafficking issues to submit their project proposals. Activities eligible for funding include direct victim support, empowerment of vulnerable groups and communities and cooperation between NGOs from countries of origin and destination. The amount of the Small Grants available

are between USD 30,000 and USD 50,000 for each selected project. The final number of projects selected (10 to 16) will depend on the actual budget requested.

The projects are geared towards the needs of the partner countries and are intended to support them in climate protection, especially reducing greenhouse gases, improving adaptability to the consequences of climate change and conserving and sustainably using climate-relevant areas which merit protection.

MS/PhD scholarships at SEARCA-Invitation to Apply for SY 2011-2012

Its people are Southeast Asia's most potent force for progress. Hence, agricultural human resource development has been SEARCA's primary goal since its establishment. SEARCA is one of the "centers of excellence" established by SEAMEO. As such, SEARCA assists SEAMEO member countries in producing highly trained human resources in agriculture and related sciences to accelerate agricultural and rural development in Southeast Asia.

Two of SEARCA's activities that carry out this mandate are the Graduate Study Program and the University Consortium. Both activities are handled by the Graduate Scholarship Department (GSD).

International workshop on Gender, Economic Integration, and Cross-border Road Infrastructure Development

As Saskia Sassen noted, globalization is a process of differentiation. This workshop discusses how regional economic integration strengthened by cross-border road networks has differentiated effect based on gender, ethnicity and class.

Asia has historically experienced high intra-mobility of goods and people, but in the recent years, the quantum of such mobility has increased dramatically. Various factors have contributed to this increase, including economic disparity within the region; differences in economic/ employment/business opportunities; transportation and communication infrastructure development, education opportunities, and a wider network of migrants in major cities and industrial areas in the region.

The workshop explores how mobility of goods and people are changing as a result of road infrastructure development and economic integration policies, how such changes affect the livelihoods of the people along the road, and how such changes further affect the way of life and practices of local women and men, especially in terms of gender-based power relations. The effects can be varied for different communities, ethnicity, gender and age, and their coping/ adaptation strategies will also be different.

Scholarships for International Master of Science in Fire Safety Engineering

The Universities of Edinburgh (UK), Ghent (Belgium) and Lund (Sweden) submitted a winning proposal for an Erasmus Mundus Master Course in Fire Safety Engineering. The initiative is carried by Prof. Bart Merci (Ghent University, co-ordinator), Prof. Jose Torero (University of Edinburgh) and Prof. Robert Jönsson (Lund University).

The curriculum concerns a two-year programme. The classes in the first semester, covering basic topics in Fire Safety Engineering (FSE), can be attended in Ghent or Edinburgh. All students spend the second semester in Lund, where emphasis lies on enclosure fire dynamics, risk analysis and human behaviour. In the third semester, classes are again taught in Ghent (for general FSE) or Edinburgh (with focus on structural engineering in the context of FSE). The fourth semester is devoted to the Master's thesis, hosted by one or more of the three institutes.

Erasmus Mundus-scholarships for non-European students are to be considered as "full scholarships" covering all necessary costs of the student during his/her study period in Europe. Over 2 years, the total amount of the scholarship is € 48,000. This amount of € 48,000 includes a fixed contribution of €8,000 to travel and installation, a contribution to the EMMC participation costs of € 8,000 per year (covering the annual tuition fees), and monthly installments of € 1,000 per month.

The Erasmus Mundus-scholarship for European students is considered as a "financial contribution". Over 2 years, the total amount of the scholarship is € 20,000. This amount of € 20,000 includes a contribution to the EMMC participation costs of € 4,000 per year (covering the annual tuition fees), and monthly installments of € 500 per month.

The Cartagena Protocol on Biosafety seeks to protect human health (including food safety) and biodiversity from the potential risks created by the use and dissemination of living "Genetically Modified Organisms" (GMOs), while taking into account socio-economic considerations.
